I. Executive Summary

uring the 2017 period, COMFREL, its staff members, its board members, and member organizations at all levels carried out activities based on the project title in COMFREL's annual work. COMFREL has achieved the following:

A-The Core Programme

Advocacy Programme (ADP):

One roundtable discussion and 6 press conferences were conducted at the COMFREL office to present the final assessment of the 2017 Commune/Sangkat Elections, to present the verification of the preliminary electoral result, and to present the first assessment on vote counting and declaration of election result. The conferences were also to update stakeholders on the environment of polling stations on the polling day and to present findings on the preelection day situation. There were 240 (20% female) participants including domestic and international journalists, ambassadors, donors, and other relevant stakeholders. The recommendations were discussed among the participants and NEC in order to reach a mutual understanding.

13 meetings were held at the COMFREL office to develop consensus and collaboration for recruiting, training and, deploying the observers. This included capacity building on methods for observation, delivery and information access, and updating information. The meetings also served as a forum to share findings on CEC recruitment and selection, candidate registration, and to discuss its findings for the report on VRM, and the primary voter list and VRA. The meetings brought partner organizations together directly (and their supporting donors indirectly) to develop joint proposals for the NEC. In addition, the meetings were used to brief stakeholders on the complaints process, and to disseminate COMFREL/ CSOs partners' findings and recommendations related to risk assessment for the election. 162 participants attended the meetings (20% female) including representatives of donors, the NEC, CSOs partners, and other relevant stakeholders.

The 2016 report on "Democracy, Elections, and Reform in Cambodia" was produced and uploaded on COMFREL's website and Facebook page. 150 copies of report were printed and distributed to stakeholders.

In cooperation with the civil society organizations, 51 recommendations were produced and submitted including 29 priorities, to the NEC related to regulations and procedures for updating the voter list in the 2017 voter registration. 18 of 29 (https://goo.gl/SMiiLe) priority recommendations were endorsed by the NEC.

Media Program (MEP):

During the reporting period, 369 (206 live and 163 rebroadcast) sessions of "VOC" radio programs were hosted with a total of 299 speakers (23% female), which facilitated outreach and public awareness on a multitude of issues. In addition, 906 people (18% female) called-in to the program to express opinions, make requests, and ask questions to the speakers. After broadcasting and uploading to the website, there were total of 68,002 downloads of the radio programs from COMFREL's website including 23,485 downloads from "Voter's Voice", 12,960 from "Human Rights", 10,292 from "Women Can Do It", 8,275 from "Weekly Watch", 8,923 from "Youth Program" and 4,067 from "Critical Law".

1475 articles and press releases were issued, including 1440 articles and 35 press releases posted on COMFREL's website and Facebook page related to election issues and laws, democratization, the National Election Committee policies and procedures, and the voter registration mechanisms and process.

Besides the radio programme, COMFREL used social media to disseminate information. There were 35,142 page views on COMFREL's website: www.COMFREL.org, and 23,146 page views on COMFREL's Election Campaign Website "Cambodian Voter Voice". COMFREL's Facebook page reached 96,162 'likes' and CVV also reached 9,053 'likes'.

31 animation video spots were produced to educate the public about the electoral process, COMFREL's work, and procedures and policies for elections. These animation video spots had 4,709,246 views 85,063 shares, 185,334 likes and more than 1450 comments on COMFREL's Facebook page.

Monitoring Program (MOP):

The 2016 annual government watch report (<u>https://goo.gl/WnkLLK</u>) was produced, uploaded on the COMFREL website and 150 copies were and sent to relevant stakeholders.

There were nine forums on voter scorecards and government fulfilment of platform promises with 184 (37% female) participants in nine provinces such as Kampong Chhnang, Kratie, Tbong Khmoum, Kampong Thom, Pursat, Mondulkiri, Preah Vihear, Kampong Speu and Siem Reap province. These were attended by university students, youth, garment workers, activists and NGO representatives. All participants had an opportunity to give a score twice on the government's fulfilment of platform promises two times, pre-test and posttest.

The 2016 Annual Parliamentary Watch report (<u>https://goo.gl/HvAzFd</u>) was launched to present findings and recommendations on NA Reform. This was attended by 38 participants (13% female) from media outlets, CSOs, and political parties.

1756 field visits were made by 81 MPs from the two main political parties. 41 CPP MPs conducted 741 field visits including 327 made by 10 female MPs while 40 CNRP MPs conducted 1015 field visits including 127 visits made by 5 female MPs. The 741 field visits by CPP MPs included 21 interventions, 442 constituency visits, 267 party support activities, 0 forums, and 11 visits accompanying a the delegation while 1015 CNRP visits consisted of 9 interventions, 171 constituency visits, 766 party support activities, 3 forums and 66 visits accompanying a delegation.

There were three plenary sessions of the NA, 7th, 8th and 9th plenary sessions with a total of 33 agenda items adopted by the NA.

Gender Program (GEP):

During the reporting period, 28 sessions (17 live and 11 re-broadcast) of 'Women Can Do it' radio program were hosted on FM 105 and 47 (36% female) speakers facilitated. During those shows, 39 (86% female) people called-in to express their opinions, ask questions to the speakers, and make requests to the government.

The annual report on Political Gender Watch, titled 'Women Parliamentarians and Women Observation of the Fourth Mandate Commune Council Electoral Registration 2016', was produced and launched to present its findings. The event occurred at the COMFREL office and was attended by 31 participants (18 female) including domestic journalists, CSOs, donors and relevant stakeholders. This report was also uploaded to the COMFREL website.

10 female short-term observers were trained and deployed for monitoring in 6 districts and 10 communes. Moreover, there were 112 female longterm observers deployed for monitoring in 12 districts, 57 communes within the five provinces of Kampong Cham, Kampong Chhnang, Takeo, Preah Vihear, and Kampong Thom in order to observe the election campaign, and polling and counting days.

In cooperation with CPWP and other NGO partners, the International Women's Day Campaign, meetings, workshop, two press conferences and one meeting were held to create space for women from different groups to share their concerns and priority issues, to build solidarity among women's groups in advocating for policy change, and to channel "Women's Voice for Women" to the public. Another objective was to inform participants about the RCEP (Regional Comprehensive Economic Partnership). In these events information, findings, and key concerns were disseminated to increase awareness related to the situation of women candidates for the fourth commune council election 2017.

B- Election Projects: Voter Registration:

49 meetings were held with all members to discuss, recruitment, trainings and deployment of observers, intervention groups, biding and T-shirt printing, and press conferences on polling and counting day. The meeting also detailed discussion of the materials for observers, reports, guidelines and procedures, animation video spots, and recruitment and the deployment of observers.

In the reporting period, various materials for both LTOs and STOs were developed including: the guidelines and questionnaire for L2P, the checklists for the observers to monitor the PEC recruitment/selection and the election campaign, the manual and the questionnaires for monitoring the polling process, and questionnaires for the counting process. 31 animation video spots were produced and disseminated to the public to educate the voters about the electoral campaign, procedures, and process. The profiles were compiled of the 12 political parties which registered candidates for the commune election. The results of PEC selection were compiled as well. COMFREL printed 15,500 T-shirts and 15,000 manuals for the observers. Furthermore, COMFREL staff produced a checklist, guidelines, manual, agenda and the questionnaires for provincial secretaries to monitor the updating of the voter list in the 2017 voter registration.

A reflection roundtable was held with its members at the COMFREL office, which was attended by the provincial secretaries, NGOs partners and COMFREL central staff. The reflection mentioned the SWOT analysis of the recruitment, training and deployment observers as well as working process.

COMFREL, in cooperation with its members, its network and provincial secretaries, recruited and selected 11,380 observers, 1,587 mobile observers (750 female), and 309 long-term observers (94 female). The observers were trained and deployed in 1,646 communes, which were moderated by the provincial secretaries and central office staff.

COMFREL conducted 1,346 trainings in communes to teach 11,380 observers how to observe on polling and counting days, as well as to collect a record of the electoral result note (1102 form) and transmit it to the central office.

There were 3 trainings of trainers and 45 trainings with 642 participants including long-term observers and short-term observers. The topics and related skills in the trainings included understanding and monitoring capacity of: electoral campaigns, voter registration audit (List to People method), polling, counting, and repeat survey and the strategies of voter list update and voter registration observation in 2017.

The reports on voter registration monitoring and voter registration audit were produced in both Khmer and English versions, and 150 copies were printed and disseminated. These reports were also uploaded on the COMFREL website and sent to the NEC. After the Commune Council Election, COMFREL produced the Final Assessment and Report on the 2017 Commune Council Election in English (https://goo.gl/62R6CC). COMFREL also produced important chronologies of the commune council elections (https://goo.gl/bNVXXh).

C-Special Projects (SPP):

16 meetings were conducted to address and evaluate the UPR Mid-Term review in regards to recommendations suggested by member states and to update stakeholders on human rights practices in Cambodia. The related objectives were: to address concerns and potential violence, and develop a response team to minimize the impact on the election in terms of both voting and counting.

D-Monitoring/Evaluation and Capacity Building:

Some staff have attended different trainings and gained new knowledge to develop their capacity and skills.

II. About COMFREL

1. Vision

COMFREL's vision is the establishment and maintenance of democratic society underpinned by genuine multi-party competitive democratic elections designed and implemented to benefit all Cambodians.

2. Mission

COMFREL's mission is to help create an informed and favorable climate for 'Free and Fair Elections'. To achieve this mission it actively supports, through lobbying and advocacy, a viable legal framework, education to inform voters of their rights, and monitoring activities to discourage irregularities and provide comprehensive data to enable an objective, non-partisan assessment of election process in its entirety.

A key element of the mission includes conducting activities to give meaning in the period between elections through continued education and public forums to encourage citizens to participate in politics and decision-making; through advocacy/lobbying for electoral reforms and the provision of comprehensive monitoring data to enable an objective, non-partisan assessment of the fulfillment of party political platform and performance and accountability of elected officials.

3. Program objectives

External Organization:

To strengthen civil society's input based on stakeholder consultation and studies for better laws, procedures and policies in keeping with democratic and human rights commitments and principles.

To create an informed and favourable climate for free and fair elections by providing information on electoral rights, monitoring reports and building a comprehensive assessment with up-to-date recommendations.

To develop the voice of voters to hold elected officials accountable. To strengthen gender equality by increasing understanding among women and men, and enhancing the capacity of female local elected officials and activists.

Internal Organization:

To ensure the effectiveness of the proposed program activities, COMFREL build staff capacity, and strengthen its organisational development.

COMFREL has an 11 board committee including: Chairman, Mr. Thun Saray, vice chair, Mr. Sok Sam Oeun, treasurer, Young Kim Eng and 8 board members: Mr. Yim Po, Ms. Sun Chansen, Mr. Mak Chamroeun, Ms. Pok Panhavichet, Mr. Mom Sarin, Mr. Kim Sovann, Mr. Sen Set and Mr. Cheang Sokha.

III. Completed Activities

A-The Core Programme

1. Advocacy Programme (ADP)

1.1 Roundtables/ Workshops/Seminars /Conferences

On July 19th, 2017, COMFREL held a roundtable discussion on "recommendations of the updating voter list 2017" to improve awareness and understanding of the draft procedures and regulations for updating the voter list and for voter registration in 2017. The meeting served as well deepen analysis and coordinate opinions so as to and provide recommendations to stakeholders, in

particular the NEC. This was attended by 99 participants (19.20% female) including domestic and international journalists, the NEC, the EU and the US Ambassador, political parties, JICA, and CSOs.

On June 24, 2017, COMFREL held a press conference on "Overall and Ultimate Assessment on 2017 Commune/Sangkat Elections" to present the final assessment of the 2017 Commune/Sangkat Elections. This was attended by 38 participants including domestic and international journalists, ambassadors, donors, and other relevant stakeholders (statement: https://goo.gl/b5jr8X).

On June 12, 2017, COMFREL held a press conference on "Verification and Assessment on Preliminary Election Result of Commune Council Election for the 4th Mandate" to present the verification of the preliminary electoral result. It was found and announced that NEC preliminary results were 93.1% the same as the electoral result note (1102) collected by COMFREL. This was attended by 38 participants including domestic and international journalists, ambassadors, donors, and relevant stakeholders (statement: https://goo.gl/qH1dPS; https://goo.gl/Z32ZU3).



On June 05, 2017, COMFREL held a press conference on "Assessment on Vote Counting and Declaration of Election Result Notes for the Commune Council Election for the 4th Mandate". The event served to present the first assessment on vote counting and declaration of election results. COMFREL found that the vote counting process of the commune council election for the 4th mandate was conducted in accordance with regulations and procedures in most counting stations. 51 participants attended including domestic and international journalists, ambassadors, donors, and other relevant stakeholders. (statement: https://goo.gl/cJe8Vj.)

On June 04, 2017, COMFREL held a press conference on "Election Day Assessment of Commune Council Election for the 4th Mandate" at the COMFREL office to update stakeholders on the environment of polling stations on Election Day. COMFREL found that at most polling stations the environment was peaceful and the process was conducted smoothly. The event was attended by 42 participants including domestic and international journalists, ambassadors, donors, and other relevant stakeholders. (statement: https://goo.gl/RH62zr)

On June 02, 2017, COMFREL held a press conference on "Pre-Election Day Assessment For Commune Council Election for the Fourth Mandate" at the COMFREL office to present its findings on pre-election day observation. COMFREL found the technical management of election to be quite capable and improved. This was attended by 42 participants including domestic and international journalists, ambassadors, donors, and other relevant stakeholders. (Statement: https://goo.gl/3mXFHz).



On January 17, 2017, COMFREL, in cooperation with CSOs partners, conducted a press conference on the findings and recommendations of voter registration monitoring at the COMFREL office. It was attended by 30 participants (23% female) including journalists, CSOs, and relevant stakeholders.

1.2 Advocacy Meeting Partnership Events

On December 19, 2017, COMFREL staff had a meeting with United Nations (UN) at the UN office to talk about a plan of cooperation among NGOs in Cambodia. As a result of the discussion, they planned to organize one workshop with civil society organizations to deepen their collaboration.

On October 30, 2017, COMFREL staff had a meeting with the NEC at the Interior of Ministry. This meeting was focused on: 1) a request for strong cooperation between COMFREL and the NEC regarding the voter registration audit (VRA); 2) a request to the NEC for raw data on the elections; and, 3) a verification on some points with the NEC regarding the updating of the voter list and voter registration. As a result, the NEC accepted the recommendations but rejected the request for raw data for security reasons.

On October 04, 2017, COMFREL held a meeting to talk about COMFREL's participation in the updating of the voter list and 2017 voter registration. This discussion was to present a primary report on the processes of updating the voter list and the 2017 voter registration, shared challenges, plans and methods of the voter list audit, to collaborate toward possible recommendations. It was attended by 12 participants (25% female) from representatives of the NEC and CSOs.

On August 15, 2017, COMFREL had a meeting with the NEC at the Ministry of Interior (MoI). The main purpose was to present the calendar of the updated voter list and voter registration list 2017, and the estimates of eligible voter who would go to vote at voting stations.

On August 14, 2017, COMFREL staff had a meeting with the NEC to talk about irregularities of the electoral result note (1102 form) at the NEC.

On August 09th, 2017, COMFREL had a meeting with NDI about the plan for voter registration monitoring and voter registration audit for the upcoming 2017 voter registration at the COMFREL office.

On May 26, 2017, COMFREL joined a meeting held by the NEC to talk about "Electoral Campaign Regulation" at the NEC office with other relevant stakeholders.

On May 17, 2017, COMFREL staff joined a press conference held by the NEC to publicly test its indelible ink. After testing, it was found that only a few people could remove the ink. Thus, NEC decided to use five other identifying principles to prevent voter fraud (News: https://goo.gl/1YkAAm):

-Enforcing issuance of Identity Certificate Document (ICD) to voters who did not possess Khmer National ID Card, or the card was lost or broken; -Strengthening election station secretary's duties in verifying ICD or Khmer ID card of voters (by comparing real appearance with the photo and name on the identification and voter list data) before marking to certify that he/she had already voted.

- Instructing the secretary to tick in order number box of voter lists and instructing voters to tick at where the Voter's name had space in order to verify that he/she had come to vote.

- Reminding political party's agents to have the voter lists in hand, and the election observers to observe the process of document verification.

- Widely disseminating the policy of penalty or enforcement as stipulated in Article 171 of the Law on the Election of Commune/Sangkat Council, which involves a fine from 5.000.000 (five million) riels to 20.000.000 (twenty million) riels which can be ordered by the NEC regardless of any other criminal penalties to any person undermining the credibility of voting.

COMFREL had a meeting with representatives of UNOPS and the EU at the UNOPS office on 27 April 2017, to talk about a plan for recruiting, training, and deploying observers, and methods for observation, delivery, and information access.

On March 09, 2017: COMFREL had a meeting with CSOs partners to disseminate findings on CEC recruitment and selection, and candidate registration. It was attended by 23 participants (9% female) from CSOs partners.

On February 09, 2017: COMFREL in cooperation with CSOs partners had a meeting with NEC to discuss the findings of the report on VRM, the primary voter list and VRA. COMFREL also had some questions regarding the first voter list. There were 11 people in attendance (9% female) including representatives from CSOs partners and the NEC.

On February 09, 2017: COMFREL had a meeting with CSOs partners to develop a proposal for the NEC to conduct a joint study and create recommendations to update the voter list in 2017 while preventing missing names and double names on preliminary voter list, and for the promotion and protection of the voting rights of migrant workers living abroad, monks, and accused detainees. There were 17 participants (18% female) from CSOs partners.

On January 24, 2017, COMFREL, in cooperation with CSOs partners, held a meeting with USAID and the US embassy at COMFREL's office to brief stakeholders on the complaints process and also on CSOs partners' recommendations COMFREL/ related the regulations of the 2017 to commune/Sangkat elections. It was attended by 8 participants (no women).

On January 5-6, 2017, COMFREL held a meeting with the NEC to discuss the recommendations on the 2. Media Programme (MEP):

2.1 Broadcasting Radio Programme

Radio Broadcasts

COMFREL's media unit's ongoing activities are as follows:

Continuation of the broadcasting of information on COMFREL's activities.

Live broadcasting of COMFREL's radio programme the Voice of Civil Society (VoC) via FM105 Radio station every day from 7:30 to 8:30 am Monday to Friday. The Voice of Civil Society consists of daily programmes on differing topics:

draft procedures and regulations for the 2017 commune/Sangkat elections. It was attended by 13 participants (3 women and 1 youth).

1.3 Studied **Reports/Statements** and **Recommendations**

produced the COMFREL 2016 report on "Democracy, Elections and Reform in Cambodia" and uploaded on its website and Facebook page. 150 copies of report were printed and distributed to stakeholders (https://goo.gl/FX3n3p).

COMFREL in cooperation with the civil society submitted 51 recommendations including 29 priorities, to the NEC related to regulations and procedure of updating the voter lists in the 2017 voter registration. 18 recommendations of 29 (https://goo.gl/SMiiLe) priorities recommendations were endorsed by the

3. Monitoring Programme (MOP):

3.1 Government Watch and Score Card on Fulfilment of the Government Platform Promises

 \Box Forum on voter score cards and

the government's fulfillment of platform promises:

COMFREL conducted nine forums on voter scorecards and government fulfilment of platform promises with 184 (68 female) participants in nine provinces including Kampong Chhnang, Kratie, Tbong Khmoum, Kampong Thom, Pursat, Mondulkiri, Preah Vihear, Kampong Speu and Siem Reap province. These were attended by university students, youth, garment workers, activists and NGO representatives. All participants had an opportunity to give a score on the government's fulfilment of platform promises two times, pre-test and post-test. Four sectors of governance were touched on by the indicators included in the assessment:

- Sector 01: National defence, security and public order
- Sector 02: Strengthening the public administration, decentralization and de-concentration, code of conduct and judicial system and anti-corruption
- Sector 03: Economic development
- Sector 04: Education development, health, employment, culture and social affairs



□ Report of government watch and score cards:

COMFREL produced the 2016 annual Government Watch report, uploaded it on its website, and printed 150 copies of report which were disseminated to relevant stakeholders (https://goo.gl/WnkLLK).

3.2. Parliamentary Watch and Tracking/Scoring and Ask the MP (Members of Parliament)

□Monitoring and an assessment of elected officials' performance:

+Field Visit

COMFREL staff collected information on MP field visits utilizing MP's Facebook and media including RFI, VOA, RFA, Everyday, DAP news, Koh Santepeap, Phnom Penh Post and Cambodia Daily. COMFREL staff also collected information on these activities from its provincial secretaries. As a result of this observation and investigation, it is calculated that 1756 field visits were made by 81 MPs from the two main political parties. 41 CPP MPs conducted 741 field visits including 327 made by 10 female MPs while 40 CNRP MPs conducted 1015 field visits including 127 made by 5 female MPs. The 741 field visits by CPP MPs included 21 interventions, 442 constituency visits, 267 party support activities, 0 forum and 11 accompanies with the delegation while 1015 consisted of 9 interventions, 171 constituency visits, 766 party support activities, 3 forums and 66 accompanies with the delegation.


+Parliamentary plenary sessions

COMFREL staff observed three plenary sessions of the NA, 7th, 8th and 9th plenary sessions with a total

of 33 agenda adopted by the NA. The monitoring assistants observed the 7th plenary session with two agenda items on 31 January and 20 February 2017. In the 8th plenary session, there were 5 sessions with 10 agenda items on 07 April, 16 May, 20 June, 20 July and 11 September 2017. Also, COMFREL observed the 9th plenary session with 21 agenda items on 05, 12 and 16 October, 17 and 27 November and 07 and 08 December 2017.

Quarterly and annual reports:

On February 21, 2017, the 2016 Annual Parliamentary Watch report was launched to present findings and recommendations on NA Reform. This was attended by 38 participants (5 female) from media outlets, CSOs, and political parties (https://goo.gl/HvAzFd).



3.3 Monitoring of Political Related Corruption and Misuse of State Resource

COMFREL produced the 2016 annual report on politically related corruption and misuse of state resources but didn't publish it.

4. Gender Programme (GEP):

4.1. Radio Call-in Show 'Women Can Do It'

In cooperation with the media unit, the civic education unit hosted 28 sessions (17 live and11 rebroadcast) of the 60 minute radio call-in show, 'Woman Can Do It', on FM 105. The programme discussed women in elections, politics and the promotion of women in processes of decision-making.



The objectives of the discussions were to strengthen women's confidence in their job performance, enhance gender equality, and motivate all political parties to consider placing women on their candidate lists. The radio shows featured feedback and interaction by allowing listeners to call-in and share their ideas, experiences, and/or to raise the questions. There were 47 (36% female) callers and 39 (86% female) speakers. The topics were:

• Action Plan to Increase the Number of Women Leaders in Communes

• Women and the Role of the Commune/Sangkat Council

- Method to Vote for Female Candidates
- Political Gender Watch
- Women and Elections
- Women and the Process of Commune/Sangkat Council Elections

4.2. Political Gender Watch (Monitoring of

Women Elected and Women's Political Participation in Politics)

The Education and Gender Unit produced the report on the Political Gender Watch, titled 'Women Parliamentarians and Women Observation of the Fourth Mandate Commune Council Electoral Registration 2016', and launched the report on 27 April 2017 to present its findings. The launch event was attended by 31 participants (18 female) including domestic journalists, **CSOs** donors, representatives, and other relevant stakeholders. The report was also uploaded to the COMFREL website.

4.3. Joint Actions for Women's Political Empowerment and Leadership

On December 22, 2017, COMFREL staff attended a meeting organized by SILIKA (CPWP) to get updated information from the Ministry of Women's

Affairs (MoWA) regarding our previous input/comment and discuss ways forward to engage with the MOWA in a meaningful ways.

On August 29, 2017, COMFREL staff joined a Consultative Workshop on "CSO's Perspective on Cambodia Sustainable Development Goals". The main objective was to provide updated information on the SDGs and CSDGs localization processes in Cambodia; to introduce the existing mechanism (Technical Working Groups) for CSOs engagement with SDGs and CSDGs, to increase awareness and mainstream "Gender" to all CSOs partners and stakeholders; and, to discuss the common action plan of CSOs toward CSDGs. The participants got update information of SDGs and CSDG and the mechanism for CSO engagement in CSDGs was introduced to CSO partners and stakeholders.

On June 29, 2017, COMFREL in cooperation with CPWP hosted a press conference on 'The Number of Elected Woman Candidates in the Commune Council Election 2017 for the 4th Mandate". There were 21 participants (12 female) including domestic and international journalists and CSOs. Its purposes were to present information on elected women candidates for the fourth commune council election 2017, and to call for the Ministry of Women's Affairs to take more action to increase the number of women in politics.



The Education and Gender Unit trained and deployed 10 short-term observers to observe in 6 districts and 10 Communes. Moreover, there were 112 long-term observers deployed including 12 districts and 57 Communes in five provinces to observe: Kampong Cham, Kampong Chhnang, Takeo, Preah Vihear and Kampong Thom to observe election campaign, Cooling, polling and counting.

On May 09, 2017, COMFREL in cooperation with the CPWP organized a conference on "The Result of Observation on Women on the Candidate Lists for the Fourth Mandate Commune Council Election 2017". There were 40 participants (28 female) including domestic and international journalists, CSO representatives, and other relevant stakeholders. Its purpose was to present information on Women Candidates for the 4th Commune Council Election 2017.

On March 05, 2017, COMFREL, in cooperation with the CPWP and other NGO partners, joined the International Women's Day Campaign at the Lila Center. The theme for this year was "Cambodian Women Changing for Peace and Development". The event served to review important issues for Cambodian women and the progress from last year, to create space for women from different groups to share their concerns and priority issues, to build solidarity among women's groups in advocating for policy change, and to channel "Women's Voice for Women" to the public.

On January 06, 2017, COMFREL, in cooperation with CWPC, held a meeting at the SILAKA office to talk discuss, analyse and improve understanding of the RCEP (Regional Comprehensive Economic Partnership, preparation for International Women's Day, and designating a resource person to facilitate on the workshop of the Women for Development Network, to be held in Siem Reap province.

B- Election Projects: Voter Registration

5. Election Monitoring and Audit: Core Team

5.1. Material Development and Training for Observers

During the reporting period, COMFREL held 49 meetings with all members at the COMFREL office. These functioned for dialogue and collaboration related to the recruitment, trainings and deployment of observers, the intervention group, the biding and printing of observer T-shirts, press conference on polling and counting day. The meeting also detailed the materials for observers, reports, guidelines and procedures, animation video spot and recruitment and the deployment of observers.

On August 07, 2017, COMFREL undertook a reflection roundtable with its members at the COMFREL office. This was attended by the provincial secretaries, NGOs partners and COMFREL central staff. The reflection mentioned the SWOT analysis of the recruitment, training and deployment observers as well as working process. The event was facilitated by the Independent analyst Meas Ny.

5.1.1. Material Development

In the reporting period, COMFREL staff developed various materials for both LTOs and STOs, including: the guidelines and questionnaire for L2P; the checklist for observers to monitor PEC recruitment and selection, and the election campaign; the manual and the questionnaires for the polling process; and, questionnaires for the counting process and election campaign. Also, COMFREL produced two animation videos to teach the STOs and LTOs the polling and counting procedure and ethic of observers, as well as animation video spots to educate voters about the electoral campaign, procedures, and process. COMFREL staff compiled the profiles of 12 political parties which registered candidates in the commune election, and the results of PEC selection. COMFREL printed 15,500 Tshirts and 15,000 manuals for observers. Furthermore, COMFREL staff produced a checklist,

guidelines, manual, agenda and the questionnaires for provincial secretaries to monitor the updating of the voter list in the 2017 voter registration.

5.1.2. Recruitment and Selection of Observers

COMFREL in cooperation with its members, its network and provincial secretaries, recruited 11,380 observers (32% female), 1,587 mobile observers (47% female) and 309 long-term observers (30% female). The observers were trained and deployed in 1,646 communes, and monitored and supported by the provincial secretaries and central office staff. Also, COMFREL recruited and selected 103 observers (23 female) to monitor voter registration in 103 communes in 6 provinces.

5.1.3. Training

On August 29-30, 2017, COMFREL held a training of trainers on "Strategies of Voter List Update and Voter Registration Observation in 2017". The main purpose was to impart skills of observing and collecting data on the voter registration process, the ability to use Gwatch and VRS programs. This training also served to educate observers about the ethics code to observers and to present the plan for observer deployment as well as criteria for tangible evidence of irregularities. This was attended by 34 participants (41.18% female) including COMFREL provincial secretaries and COMFREL staff.

COMFREL provincial secretaries conducted 6 trainings with 103 observers (23 female) in 6 provinces including Koh Kong, Kampong Speu, Kampong Thom, Kangpong Cham, Kanal and Banteay Meanchey province. The participants were trained on how to observe the voter registration process.

COMFREL trainers (network members) conducted around 1,346 trainings in communes to teach 11,380 observers how to monitor both polling and counting processes, as well as collect the electoral result note (1102 form) which needed to be transferred to the central office.

On May 14-15, 2017, COMFREL held a training of trainers with 30 participants (12 female) including 25 provincial secretaries, at the COMFREL office to train network members on financial spending and reporting formats, distribution of the training manual, understanding checklist and payments, election related procedures, regulations (i.e. campaign, complaining, voting and counting and complaints), and codes of conduct, and on how to seek assistance when at risk. This training resulted significant improvements in understanding the new election regulations and provisions. These 25 provincial secretaries were prepared with the knowledge, skills, and teaching techniques to be master trainers and effectively train election observers in their respective provinces, and impart important peace-building and non-violent communication skills which are integrated in the training manuals.

After providing the trainings of trainers, COMFREL provincial secretaries held 24 trainings on "Electoral Campaign" on 18 May 2017 with 314 participants (84 female) and 24 trainings on "Polling, Counting day and Repeat Survey" on 28 May 2017 with 348 participants (98 female) as long-term observers in 24 capital and provinces. These people would train to other people in the commune.

On January 21-24, 2017, COMFREL provincial secretaries conducted 21 training sessions for 269 observers (81 women and 111 youth) on "Voter Registration Audit". The training sessions took place in 21 provincial capitals. Observers assigned to each province were trained separately, though due to their small size, the Kep and Stung Treng observer teams were trained alongside the Kampot and Kratie teams, respectively. After two days of training, all observers were deployed to their respective target areas for voter registration audit survey.

On January 16-17, 2017, COMFREL conducted a training of trainers (ToT) on "Voter Registration Audit (List to People)" at COMFREL's central office. The training increased participants' knowledge and capacity to perform a voter registration audit (L2P). The training was attended by 24 provincial trainers (10 women and 3 youth).

5.2 Deployment of Monitoring and Observers

After the Commune Council Election, COMFREL deployed 103 observers (22.33% female) to monitor voter registration in 103 communes in 6 provinces. COMFREL also deployed 300 observers to conduct pre-election monitoring on the registration of candidates, and the selection of PEC and CEC, which started in January and finished on 18 April 2017. In May, COMFREL deployed the same observers to observe the election campaign. The pre-election day assessment for Commune Council Election of the fourth mandate was produced and posted on its website as well as conducted a press conference at COMFREL office on 02 June 2017. (Statement: https://goo.gl/3mXFHz).

5.3 Reporting

COMFREL produced reports on voter registration monitoring (https://goo.gl/4LKvNS) and voter registration audit (https://goo.gl/Vrnfqu) in Khmer and English versions. These reports were also printed 150 copies and disseminated to relevant stakeholders as well as uploaded on its website. Moreover, COMFREL produced a pre-election monitoring report and overall and ultimate assessment on the commune council election for the 4th Mandate. After the Commune Council Election, COMFREL produced the Final Assessment and Report on the 2017 Commune Council Election in English (https://goo.gl/62R6CC). COMFREL also produced the important chronologies of the commune council elections (https://goo.gl/bNVXXh).



C-Special Projects (SPP)

6. Project on Strengthening the Defense of Human Rights in Cambodia and Myanmar (SDHR): NEU

On June 16, 2017, COMFREL had a meeting with OSI security specialists to consult and collaborate regarding the threats with regards to legal harassment by the executive, both directly and indirectly, to COMFREL and its members. OSI agreed to assist in future training in terms of security risks and ICT potential threats, including an emergency fund for resettlement if legal and physical harassment is be targeted against COMFREL core staff or Executive Director.

On June 15, 2017, COMFREL had a UPR mid-term meeting with members of CSOs at the CCHR office to address and evaluate the UPR Mid-Term review in regards to recommendations suggested by member states. There were a total of 10 participants (3 female). UPR Info and International Commission of Jurists (ICJ) suggested members of CSOs consider drafting a summary of their fact finding following their mandate and expertise and submit it to CCHR for the compilation with concrete recommendations on specific issues. All of the representatives agreed on the proposals of UPR Info and ICJ expressed support and their plan to participate in the national consultation workshop which was held from June 29-30, 2017 with multiple relevant stakeholders and government agencies, including the OHCHR in Cambodia.

On May 29, 2017, COMFREL had a meeting with the UN special rapporteur at the COMFREL office to update relevant UN bodies regarding human rights practices in Cambodia in relation to the midterm review of UPR. It was an unofficial visit to see the environment of the upcoming election and human rights related issues. COMFREL and the Working Group on Intervention addressed intimidation and challenges for observers and political participations of citizens, including the issues raised and discussed by HRDs during the national conference consultation workshop. The UN Special Rapporteur with the support of the UNOHCHR committed to close monitoring and its members regarding intimidation and harassment, government diplomatic efforts with and representatives in support of human rights work to reduce challenges HRDs face. The UN Special Rapporteur acknowledged those challenges and expressed his on-going support for both the RGC and CSOs in terms of assistance and collaboration for the improvement of human rights practices in Cambodia.

On May 16, 2017, COMFREL had a meeting with SDHR team at the COMFREL office to update the COMFREL team and network, CSOs, and relevant stakeholders regarding the situation of human rights practices at their respective community and the upcoming activities planned (i.e. network meeting, regional exchanges and regular meeting with concerned authorities and NGO partners. The vast majority of them expressed their optimism over the improvement of cooperation between HRDs and local authorities, but expressed concerns over election related tensions. Team agreed to conduct activities after the election, and foment further improvements in cooperation with local authorities in addressing human rights abuses and intimidation. The details of human rights practices and related accomplishment within these few months would be reported in the network meeting in July 2017.

On May 09, 2017, COMFREL had a meeting with the NEC security working group at the Ministry of Interior to address concerns and potential violence, and response team to minimize the impact of serious problems during both voting and counting. The NEC, in cooperation with the Ministry of Interior, would deploy at least 100,000 security personnel across the country including patrol teams to ensure the safety at the polling stations and of the candidates of each party. Representatives of some organizations applauded the action taken by NEC and MoI, but cautioned that such a massive deployment could intimidate voters unintentionally. There were 32 participants (12 females) from different organizations.

On May 05, 2017, COMFREL had a meeting with the intervention team to prepare the training manual for the observers on the ground and assist NGOs partners in the areas of training and assessing potential risks for observers. The team also agreed on the proposed budget for the intervention and investigation mission of ANFREL along with the training of observers. ADHOC along with CVS would head to the North of the country in case of immediate intervention needed as those provinces were 'on alert' for potential intimidation and violence against observers. LICADO would cover central parts of the country around Phnom Penh, but would cooperate with ADHOC for intervention. COMFREL and CLEC would cover the East of the country monitoring polling stations and assisting observers who lacked a sound understanding of the data transmission process. COMFREL staff would coordinate the cases and seek remedies.

On April 28, 2017, COMFREL had a meeting with the intervention team to update partners on the situation of the upcoming election, and action-plan to assist observers who are at risk on the ground. The team agreed on the deployment of Nationwide Mobile Observers to assist observers at areas of potential unrest or confrontation. The team also developed plans to communicate concerns and challenges to their partners and donors, including foreign embassies in Cambodia for their support, in case of any emergency. The team finished the draft of poster highlighting the Code of Conduct and emergency contact details to the Secretariat. There were a total of 6 participants, representing CCHR, CLEC, ADHOC, LICADO, and COMFREL (1 female).

On April 06, 2017, COMFREL had a meeting with the intervention team to review the draft policypaper and mechanism to train 100 HRDs in SDHR, and for the expected 10,000 volunteer election observers regarding personal safety and how to respond when they face physical or legal harassment. The team collaborated to finalize the draft the policy-paper and the draft training manual for the training of its members which would take place on May 8, 2017 at COMFREL. There were a total of 8 representatives (2 COMFREL personnel, 2 from LICADO, 1 from ADHOC, 2 from CCHR, and 1 from CLEC) (3 female).

On April 04, 2017, COMFREL had a project meeting with CORD Cambodia to prepare the questionnaire and checklist for the SDHR Project Inspection and Case Study Development in Preah Vihear province from April 10-12, 2017. The team agreed to meet with the commune councillor from CPP, a representative of the community in the protected forest, and chief of the Forestry Department in Preah Vihear, in order to document progressive changes related to peace-building, nonviolent communication, and rights based approaches to environmental and forest protection. The team also discussed the 3rd round coaching for Region II from April 24-27, 2017 and the training on PB & COP for Region III on May 5-11, 2017, as well as updated the participants on progress of the SDHR in Myanmar and the preparations for the national conference in late June 2017.

On February 23, 2017, COMFREL had a WGPD quarterly meeting at the Ministry of Interior (MoI) with 13 participants (6 female). The objective was to update government officials and civil society on the achievements and challenges of decentralization work in 2016 including: an action-plan and milestones of decentralization efforts for the year 2017. There were significant achievements in 2016, including multiple meetings between local authorities and representative of communities, to address challenges and needs of the communities. COMFREL also input concerns, challenges, requests, and recommendations discussed by HRDs during the regional and national workshop (specifically, land grabbing issues and the restriction of rights to assembly and expression by the local authorities) in the draft policy paper and recommendations to the MoI and its agencies.

On February 16, 2017, COMFREL had a meeting on "LANGO Law" with its network at the CCC office to address potential challenges of CSOs regarding the passing of NGO Law, and other related regulations. The checklist was jointly-developed by members of CSOs to evaluate potential risks and chart room for improvement needed in order to effectively and fairly implement the LANGO Law. There were a total of 12 people (5 female, 7 male) -1 COMFREL, 1 ADHOC, 3 CCC, 2 USAID Cambodia, 1 LICADO, 2 CCHR, 1 TI Cambodia and 1 CLEC. There was also a discussion on the legitimacy of the law and whether NGOs should comply with it or contest it on the basis that the law would be selectively implemented, targeting only NGOs that work on the field of human rights and governance. Additionally, coordination occurred to advance the working group to study the impact of RGA2's reform effort related to the judiciary and decentralization. The working group was formed and will produce a research paper and consult for the output of its members, including COMFREL.

On February 06, 2017, COMFREL had a meeting with its network at CORD office for collaborative reflection on SDHR Year II accomplishments and challenges for the project "Strengthening the Defence of Human Rights in Cambodia and Myanmar". There were a total of 10 people in attendance (3 female, 7 male), including representatives from Cord Cambodia, COMFREL, FACT, CYN, CIYA, CDPS, CCFC.

On February 09, 2017, COMFREL staff joined a launching at the MoI for the "My Open Village" project in five provinces to promote good governance and transparency. There were a total of 26 people (12 males, 14 females), a representative of provincial level from 5 different provinces, NGO partners, MoI officials and media outlets representative; and officials of USAID Cambodia.

On January 31, 2017, COMFREL had a meeting with CSOs at the CCC office to update interested organizations regarding political, economic and social issues. A key focus was strategic discussion on scenarios and actions to be taken by CSOs for

2017 and beyond promoting the rule of law and democratic development in Cambodia and key events (such as diplomacy talks on Paris Peace Accords, Community of Democracy event, and Asean Democracy Network - ADN) which would be convened to enhance regional and international networks. The team also agreed to form a group of 7 representatives to draft the policy paper focusing on reform needed and challenges faced by CSOs and to what extent they can still expect and support the government to enhance democratic practices and the rule of law. The draft policy research was put forward for consultation in the workshop involving members of CSO and stakeholders. The event functioned to strengthen networking among members of CSO, and provided all participant NGOs a forum to present their concerns and fact finding results along with concrete recommendations for the purpose of advocacy and engagement with government officials and agencies.

On January 25, 2017, COMFREL had a meeting with ADHOC, CCHR, ActionAid and CHRAC at the CCHR office to collaborate on increasing public outreach to generate public support and attention, both locally and internationally. **Participants** developed strategies for public campaign, endorsement of joint statements calling the release of those HRDs. They also discussed and cooperated in relation to trial monitoring, and lobby of influential figures such as diplomats and politicians to increase pressure towards an end to excessive pretrail detention and release of the political prisoners. The 5 HRDs were nominated for the Martin Ennals Human Rights Defenders Award, and Tep Vanny

would be nominated by CCHR for the Gwangju Human Rights Award.

On January 17, 2017, COMFREL had a meeting with CORD and one consultant at the CORD office to discuss the development of the manual for training for representative HRDs and HROs. The manual focused on leadership and accountability in order to enhance the capability of those HRDs and HROs. The training plays a crucial role in terms of capacity development of representative HRDs and HROs and contributed substantially to both personal leadership and professional development. The training materials and curriculum emphasized the essential role of youth and gender diversity in leadership, empowering participants.

On January 12, 2017, COMFREL had a meeting with the technical working group on HRDs and observers security policy in order to address the necessary policy and mechanisms to minimize potential risks, and be ready if observers on the ground face intimidation and harassment. There were a total of 7 participants, representative ADHOC, CCHR, LICADO, CLEC and COMFREL (2 female).

D-Monitoring/Evaluation and Capacity Building

7. Monitoring and Evaluation

7.1. Follow up and Monitoring

On November 23-26, 2017, COMFREL conducted a staff retreat at Siem Reap and Preah Vihear province to reflect its achievements and challenges in the fiscal year 2017, and to develop the strategic plan and to boost teamwork and collaboration among COMFREL staff.

IV. Staff Development and Training

To strengthen central staff's capacity to perform roles and duties more effectively in the workplace, COMFREL fully encourages and motivates them to upgrade their skills and knowledge through workshops, training, coaching, and mentoring sessions both inside and outside the organization.

On December 19, 2017, COMFREL staff participated in a Masculinity and Gender Equality Reflection workshop at DIAKONIA office. The main objectives were to provide a safe and private space to the participants to share their successful experience, challenges and solution and continue identifying and reviewing ways to address 1) new forms of gender-based violence and 2) gender roles responsibility and rights in current context. It was also to further discuss the strategies and ways forward and strengthen masculinity and gender equality networking.

On September 06-08, 2017, COMFREL staff attended the Annual Mainstreaming Workshop organized by the DIAKONIA in cooperation with the GADC. The main objective was to continue to building partners' knowledge and skills on Gender mainstreaming, to communicate DIAKONIA's commitments to implement its strategic plan and workplaces that contribute to gender equality and to continue to seek a more effective and meaningful way for partners to include gender equality in their organization. On August 23-24, 2017, COMFREL staff attended a training, on "Gender Responsive project Design, Monitoring and Evaluation", organized by victim Support Section Extraordinary Chamber in the Counts of Cambodia ECCC, Co-organized by Ministry of Women Affairs. Its main objective was to instruct on how to set Gender statistics, to know the steps in preparing the assessment, responding to the needs of women, and to know to mainstream gender into the projects.

On August 01-02, 2017, COMFREL staff attended a NEC's training on "the updating of the voter list in the 2017 voter registration" at the National Institution of Education (NIE). There were 114 participants (4 Female) in this this training. The main purpose was to introduce the municipal and provincial secretariats from political parties and local and international NGOs about updating of the voter list in the 2017 voter registration.

On June 08, 2017, COMFREL staff attended a training course on 2nd ICT4D for advocacy group at East-West Management Institute (EWMI). Its purposes were pre-training on election data collection, gaining an introduction to WESTool, increasing experience using electronic data collection, and getting up-to-date on digital security.

On May 24-25, 2017, COMFREL staff attended a training on online security for 5 NGOs partners of NPA held by Central to secure in social media and
